Having trouble collecting parking fines from habitual offenders? There is a way to get these offenders' attention. The BMV has a system called **DETER – Drivers with Excessive Tickets Excluded from Registration**. Created in 2005, this system is designed to block renewals of, applications for, or transfers of, vehicle registrations for persons with either 3 or more unpaid parking tickets or just one single violation for parking in a handicapped space. To participate in the DETER program the information must be transmitted electronically to the BMV. The **PTTS** software has a

built-in function which can electronically send information about these tickets to the BMV's DETER system. This block can only be removed when the offender's tickets are ALL paid or dismissed. A release is then sent to the BMV so that the offender can renew his plates.

"This sounds like a lot of trouble," you might say, "How can I do this?" We're glad you asked. Parking Ticket Tracking System is a full-featured software that will keep track of all your parking tickets for you. It can also electronically send a file containing both registration block and release information to the BMV's DETER system. The entire list of features is shown below.
